Tour participants are responsible for their own food and water supplies, and should wear appropriate clothing, hats, and footwear suitable for possible snow showers and cold weather.

Following the conclusion of the tour, OHMVR Commission members may leave for a recreational ride. No business will be discussed and the public is invited to attend.
